Purposes – for what purposes do we process your data?

In compliance with the provisions of the European Regulation 2016/679 General Data Protection, we inform you that we will process the data you provide us for:

- Manage the contracting of services that you carry out through the Platform, as well as the corresponding billing and delivery.
- Periodically send communications about services, events and news related to the activities carried out by El Auténtico Cabo de Gata SL, by any means (telephone, postal mail or email), unless otherwise indicated or the user objects or revokes their consent.
- Send commercial and/or promotional information related to the contracted services sector and added value for end users, unless otherwise indicated or the user objects or revokes their consent.
- Compliance with legally established obligations, as well as verifying compliance with contractual obligations, included fraud prevention.
- Transfer of data to agencies and authorities, provided that they are required in accordance with legal and regulatory provisions.

Data categories – What data do we process?

Derived from the aforementioned purposes, at El Auténtico Cabo de Gata SL we manage the following categories of data:

- Identification data
- Electronic communications metadata
- Commercial information data. In the event that the user provides data from third parties, he/she declares that he/she has the consent of said third parties and undertakes to

transfer the information contained in this clause to them, exempting El Auténtico Cabo

de Gata SL from any liability in this regard.

- However, El Auténtico Cabo de Gata SL may carry out verifications to confirm this fact, adopting the corresponding due diligence measures, in accordance with data protection regulations.

Legitimation – what is the legitimacy for the processing of your data?

The processing of data for the purpose of sending periodic newsletters on services, events and news related to our professional activity is based on the consent of the interested party, expressly requested to carry out such processing, in accordance with current regulations.

In addition, the legitimacy for the processing of data related to offers or collaborations is based on the consent of the user who sends their data, which can be withdrawn at any time, although this may affect the possible fluid communication and obstruction of processes that they wish to carry out.

Finally, the data may be used to comply with the legal obligations applicable to El Auténtico Cabo de Gata SL

Data Retention Period – How long will we retain your data?

El Auténtico Cabo de Gata SL will retain the personal data of users only for the time necessary to carry out the purposes for which they were collected, as long as the consents granted are not revoked. Subsequently, if necessary, the information will be kept blocked for the legally established periods.

Recipients To which recipients will your data be communicated?

Your data may be accessed by those providers that provide services to El Auténtico Cabo de Gata SL, such as hosting services, marketing tools and content systems or other professionals, when such communication is required by law, or for the execution of the contracted services.

El Auténtico Cabo de Gata SL has signed the corresponding data processing contracts with each of the providers that provide services to El Auténtico Cabo de Gata SL, with the aim of ensuring that said providers will process your data in accordance with the provisions of current legislation.

They may also be transferred to the State Security Forces and Corps in cases where there is a legal obligation.

Banks and financial institutions, for the collection of services.

Public administrations with jurisdiction in the activity sectors, when so established by

current regulations.

Information Security – What security measures do we implement to protect your data?

In order to protect the different types of data reflected in this privacy policy, the necessary technical security measures will be implemented to prevent their loss, manipulation, dissemination or alteration.

- Encryption of communications between the user's device and the servers of El Auténtico Cabo de Gata SL
- Encryption of information on El Auténtico Cabo de Gata SL's own servers
- Other measures to prevent third parties from accessing user data.
- In those cases in which El Auténtico Cabo de Gata SL has service providers for the maintenance of the platform that are located outside the European Union, these international transfers have been regularized in accordance with El Auténtico Cabo de Gata SL's commitment to the protection, integrity and security of users' personal data.

Rights – What are your rights when you provide us with your data and how can you exercise them?

You have the right to obtain confirmation as to whether or not El Auténtico Cabo de Gata SL is processing personal data that concerns you.

You also have the right to access your personal data, as well as to request the rectification of inaccurate data or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes for which it was collected.

In certain circumstances, you may request that the processing of your data be restricted, in which case we will only retain it for the exercise or defence of claims.

In certain circumstances and for reasons related to your particular situation, you may object to the processing of your data. El Auténtico Cabo de Gata SL will stop processing the data, except for compelling legitimate reasons, or the exercise or defence of possible claims.

You may also exercise your right to data portability and withdraw any consents you have given at any time, without affecting the legality of processing based on consent prior to its withdrawal.
